# **Agile Tactics for Rapid Progress**

Implementing agile tactics allows for quick wins and demonstrates early progress, which is crucial for maintaining momentum during transformation. Consider these examples:

# 30-Day Plan: Focus on Quick Wins & Assessment

- Identify 1-2 key areas for immediate improvement: Focus on highimpact, low-effort initiatives.
  - *Example:* Digitizing the process for submitting and approving supplier invoices, leading to faster processing times.
- **Conduct initial stakeholder interviews:** Gather feedback and identify key pain points and opportunities.
- **Establish clear communication channels:** Implement regular updates and feedback mechanisms.
- Form cross-functional pilot teams: Engage representatives from different departments in initial initiatives.


#### 60-Day Plan: Implement & Iterate

- **Pilot the identified quick win initiatives:** Deploy the digitized invoice process in a specific department or region.
- **Gather feedback on pilot initiatives:** Assess the effectiveness and identify areas for improvement.
- **Develop initial 30/60/90-day plans for larger initiatives:** Outline key milestones and deliverables.
- **Conduct foundational training sessions:** Introduce basic concepts and tools related to the transformation.

#### 90-Day Plan: Scale & Embed

- **Scale successful pilot initiatives:** Roll out the digitized invoice process across the organization.
- **Refine 30/60/90-day plans based on pilot learnings:** Adjust timelines and strategies as needed.
- Implement key performance indicators (KPIs) to track progress: Measure the impact of implemented changes.
- **Recognize and celebrate early successes:** Highlight the positive outcomes of the initial agile tactics.
